#### **Active ingredients:**

Permethrin 0.5% w/w, tetramethrin 0.10% w/w, S-methoprene 0.05% w/w

#### **Directions for use:**

For optimum performance we recommend vacuuming carpeted surfaces immediately prior to application as this opens the carpet pile and allows the spray to penetrate. Similarly, vacuum and treat under large items of furniture, such as sofas, to target favoured hiding places of immature fleas. Remove all pets, including birds and fish, from the area to be treated.

Remove cap. Invert can. Hold can approximately 30cm away from the surface to be treated and apply spray. Use 4 seconds of spray to cover 1 square metre of surface, spraying in a criss-cross pattern to ensure uniform delivery. Remember to spray in cracks and crevices around the room (e.g. skirting boards and gaps in exposed floorboards). It is advisable to continue to vacuum regularly after spraying.
